

This provisional approval for admitting the first batch has been given on the condition that the Council in order to ensure the maintenance of Norms & Standards, shall review the performance of the college through a compliance report and if necessary, by visit of an expert committee constituted for this purpose. The approval for admission of next and subsequent batches shall only be given after review of the performance, of institute and compliance of general and specific conditions of approval. This approval is issued under following stipulations.

- a) The general conditions given at Annexure - I and the Management institute is required to constitute an Advisory Body with functions and constitution as given in Annexure - II (Enclosed).
- b) The following are the specific conditions in respect of your institute which must be fulfilled within a period of four months from the date of issue of this letter.
 1. The institute shall add 500 books on management and 4 computers.
 2. The fee shall be charged as per State Govt./ AICTE norms.
 3. The institute shall construct its own campus as per AICTE norms within one year from the date of approval.

NOTE:- The programmes requested for approval other than the above mentioned (if any) have not been recommended by the All India Board and hence not approved by the Council.
